Terms & Conditions

Agreement

1. The Client and George & Fuhrmann (Holdings) Pty Ltd ("George & Fuhrmann") agree that these terms and conditions apply to the supply of all goods, services and credit supplied by George & Fuhrmann to or on behalf of the Client.

Terms

2. The Client must pay for all goods, services and credit that George & Fuhrmann supplies within 14 days of the date of purchase for livestock or of providing other services.

Interest & Overdue Accounts

- If an amount of money is overdue, the Client shall be liable for interest (calculated on a daily basis) at the rate charged by George & Fuhrmann at its discretion from time to time.
- 4. Any unpaid interest outstanding from time to time plus any unpaid account charges are converted into Principal and deemed to be part of the Principal. Interest is charged on that Principal.
- 5. George & Fuhrmann reserve the right to withhold proceeds from the sale of livestock and apply part or all of it to the outstanding Principal and interest for the account.

Ownership & Recovery

- 6. All livestock remain the property of George & Fuhrmann until full payment has been received.
- 7. If livestock have not been paid for in full within 14 days of the purchase, the Client authorises George & Fuhrmann or its agents to at any time and without prior notice:
 - Enter any lands or premises where the livestock may be stored, and
 - Remove some or all of the livestock, and
 - Sell the livestock for any price that George & Fuhrmann sees fit and expedient as part or full repayment of the money owing
- 8. The Client must pay to George & Fuhrmann on demand all costs, fees and expenses including legal expenses on a full indemnity basis incurred in connection with the recovering of any outstanding debt owed by the Client.

GST

9. The Client is wholly responsible for informing George & Fuhrmann of any changes to GST Status prior to the sale of livestock. Where notice is not received, George & Fuhrmann will not be responsible for errors in GST on sales.

General

- 10. If the Client consists of two or more persons, this agreement binds them jointly and each of them individually and binds the legal representatives, successors and assigns of each person.
- 11. This Agreement may only be varied in writing and signed by both parties.
- 12. This Agreement is governed by the laws of the State of Queensland and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of the State of Queensland.
- 13. Any provision of this agreement which is illegal, void or unenforceable is unenforceable to the extent only of that illegality without invalidating the remaining provision of this agreement.
